	ORDINANCE APPROVING HEALTH INSURANCE FOR VILLAGE EMPLOYEES, AND DECLARING AN EMERGENCY
	WHEREAS, the Village of Weston is a statutory municipality located in Wood County, Ohio, with powers of local self-government pursuant to Ohio Constitution Article XVIII, section 3, and
	WHEREAS, the employees of the Village of Weston presently do not receive health insurance benefits, and
	WHEREAS, the Council of the Village believes it must provide certain employment benefits to its employees in order to retain its current staff and to recruit qualified candidates when positions become available.
	NOW THEREFORE, BE IT ORDAINED, by the Council of the Village of Weston, that:
	1. Full-time employees of the Village of Weston, defined as those employees who regularly work 35 hours or more in the employ of the Village, weekly, shall be entitled to health insurance coverage for the employee and the employee's immediate family, beginning the earliest effective date permitted by the health insurance policy or policies selected by the Village Council. The policy or policies of coverage shall be chosen exclusively by the Village Council, and may be modified or terminated, as determined necessary by the Village Council, in its discretion. The costs of premiums for such insurance shall be paid, in full as determined exclusively by the Village Council, by the Village of Weston.
	2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
	3. This measure is an emergency measure, necessary for the immediate preservation of the health, safety and welfare of the Village and its residents, for the reason that retaining the Village's current employees and securing qualified new employees is imperative to successful operations of the Village. And, in order to secure health insurance application must be made within a relatively short enrollment period.
